The Curriculum and Standards Committee will undertake the following:

Standards

- To review annually the School Development Plan (SDP) and to advise the Governing Body on priorities for the key areas of the curriculum;
- To liaise with the Strategic Policy and Direction Committee and ensure that adequate resources are available to meet the objectives of the School Development Plan;
- To monitor the results of initiatives within the School Development Plan, and to act upon them;
- To monitor pupil performance including that of disadvantaged groups;
- To consider curricular issues which have implications for the Strategic Policy and Direction Committee and to make recommendations to the relevant committees or the Governing Body;

- To make arrangements for reports to be received by the Governing Body from School Development discussions;
- To oversee arrangements for individual governors to take a role in overseeing specific areas of provision (eq SEN, Literacy, Numeracy), receive reports from advise the Governing Body on key actions;
- To receive reports on standards of pupil performance and target-setting, including that of disadvantaged children, and report on trends and achievements to the Governing Body;
- To consider and contribute to ongoing actions to comply with Ofsted requirements, informing the Governing Body as appropriate.

Environment for learning

- To promote a school ethos, environment and curriculum which fosters a love of learning and enquiring minds;
- To consider the views of the Headteacher and of parents/guardians of excluded pupils and delegate responsibility for exclusions of less than 5 days to the Headteacher;
- To confirm exclusions of more than 5 school days.

Pupil welfare

- To ensure that a teacher and governor are designated with responsibility for Child Protection & Safeguarding and ensure that they receive appropriate information and training;
- To ensure that a teacher and governor are designated with responsibility for Looked After Children (LAC) and ensure that they receive appropriate information and training.
